On behalf of All India Managing Committee of FBS IAP and pursuant to the 12th AIMC meet which was held on 31.07.2016 at Hyderabad, it was decided to call for the elections as per the FBS IAP Bye-Laws, as well as the recent amendments, ratified in the 2nd Special GBM held on 31.07.2016.

Take notice of this notification given for the elections for the All India Managing Committee for the 3-year term, 2017-2020 and nominations are called for the posts (Listed Below) with the eligibility criteria mentioned. Elections will be held through postal ballot.

Nominations are invited for the below mentioned posts from the All India FBS IAP Members and respective Zones & States as given below.

 - The Chairman, Honorary. Secretary and Honorary. Joint Secretary cum Treasurer will be elected from All India Members of FBS IAP.
 - Five Vice-Chairmen shall be elected from among the members from respective zones of FBS IAP.
 - All India Executive Members shall be elected from among the members of the respective states of FBS IAP as mentioned above.

NOMINATION FEE

The candidate is required to pay the applicable ‘NOMINATION FEES’ as mentioned below:

Nomination Fee for the post of Chairman is Rs.4,000/-

Nomination Fee for the post of Hon. Secretary & Jt. Secretary cum Hon. Treasurer is Rs. 3,000/-

Nomination Fee for the post of each of the Zonal Vice-Chairman, is Rs. 2,500/-

Nomination Fee for the post of the State Representative is Rs. 2,000 /-

The Nomination Fee should be paid by Demand Draft in favour of “**Family Benefit Society**”, payable at Hyderabad. The Nomination Fee should accompany the Nomination Papers, failing which the Nomination shall be disqualified.

The Nomination Fee is non-refundable.

Any withdrawals can be made before the scheduled date, provided the candidates send their written consent by a hard copy letter or by EMAIL from his/her official EMAIL ID. Please refer to the ELECTION TIME–TABLE sent along with this Election Notice for the SCHEDULED DATES related to the conduct of this FBS Election.

VALID VOTERS – Only FBS-IAP accepted members, on or before 31.03.2016, will be eligible to vote in the elections as per the norms of FBS IAP. (Only to those accepted members list provided by FBS IAP, are eligible for voting)

- A member shall be ineligible for contesting for more than one post.
- Read carefully all the details given in election notice before filling up the Nomination Form.

Eligibility Criteria of the Candidate for various posts of FBS IAP 2017 are laid down, as under:

1. CHAIRMAN: Eligibility Criteria

The candidate must have accomplished 3 COMPLETE YEARS of FBS Membership, from his Membership Acceptance date up to April 1, 2017. He should have been an All India Managing Committee Member for TWO COMPLETE YEARS, as on April 1, 2017.

2. HON. SECRETARY: Eligibility Criteria (Twin Cities or GHMC Jurisdiction)

The candidate must have accomplished 3 COMPLETE YEARS of FBS Membership from his Membership Acceptance date up to April 1, 2017. He should have been an All India Managing Committee Member for TWO COMPLETE YEARS as on April 1, 2017.

3. JOINT SECRETARY cum HON. TREASURER: Eligibility Criteria (Twin Cities or GHMC Jurisdiction)

The candidate must have accomplished 3 COMPLETE YEARS of FBS Membership from his Membership Acceptance date up to April 1, 2017. He should have been an All India Managing Committee Member for TWO COMPLETE YEARS as on April 1, 2017.

4. ZONAL VICE-CHAIRMAN (one from each of the FIVE ZONES): Eligibility Criteria

The candidate must have accomplished TWO COMPLETE YEARS of FBS Membership, from his Membership Acceptance date up to April 1, 2017.

5. EXECUTIVE MEMBERS (STATE REPRESENTATIVES): Eligibility Criteria

The candidate must have accomplished ONE COMPLETE YEAR of FBS Membership from his Membership Acceptance date up to April 1, 2017.

Candidates should send their duly filled Nomination Form along with the **non-refundable nomination fee** mentioned against the Post he/she is contesting for, by a **DD / Multi City Cheque / NEFT (A/c Name: FAMILY BENEFIT SOCIETY, A/c No: 62184506297, State Bank of Hyderabad, Gunfoundry, Hyderabad, IFSC Code: SBHY0020066)** is also accepted as Nomination Fees from a Nationalized/reputed bank, **by Registered Post, Ordinary Post or Speed Post (Indian Postal Department) and must reach the Election Office on or before 03.12.2016 by 05:00 pm to Dr. P. Venkateshwar Rao, Chief Election Officer.**

Guidelines of Elections:

- a. The election of the Office Bearers and the Executive Board Members of FBS shall be held by postal ballot as per the guidelines laid by the FBS CONSTITUTION
- b. Any member, who has any complaint about the election, shall give the same in writing, addressed to **Dr. P. Venkateshwar Rao, Chief Election Officer 2017, FBS-IAP, 2-2-1105/7/B, Tilak Nagar, New Nallakunta, Hyderabad - 500044. Telangana State**, within 21 (Twenty one) days of declaration of the results.
- c. **Nominations:** The members may file as many nominations as they desire for a single post, however payment details should be made in all the nominations and the Xerox copy of the payment proof should be attached to all such additional nominations. The name of the candidate should be mentioned on the Nomination Form as registered with FBS IAP Office records. No other change in the name will be allowed.
- d. **A member cannot contest for more than one post.** In such case, all the nominations of such member will be rejected as invalid. **A member who is a Proposer / Seconder for a candidate cannot propose or second any other candidate in the current FBS ELECTION.** In such case all the nominations proposed and seconded by same member will be rejected as invalid.
- e. **Casting of Votes:** The Voters are required to submit/attach a **self-attested Xerox copy of their Photo Identity** such as **PAN Card/Aadhar Card/Passport/Driving License** along with the Ballot Papers.

- f. **List of Voters:** The list of Voters will be frozen by the FBS Election Commission 2017, based on the eligible voters accepted on or before **31.03.2016**, as approved by FBS OFFICE.
- g. **Ballot Papers:**
- i. The FBS Election Commission shall decide on the "**Ballot Envelope**".
 - ii. Posting of Ballot Papers will be done by the FBS Election Commission 2017.
 - iii. Each member is required to send his/her ballot papers **ONLY BY ORDINARY POST** in the "**Prepaid Stamped Envelope**" provided by the FBS Election Commission 2017.
 - iv. **THE BALLOT PAPERS SENT BY COURIER OR HAND DELIVERY OR BULK MAIL WILL BE CONSIDERED AS INVALID.**
 - v. The members are required to make request for Duplicate Ballot Papers by hard copy of the letter addressed to FBS Chief Election Commissioner 2017. He/she may alternately send an email request from his Registered E-MAIL ID. If a voter does not receive Ballot Paper, the request for Duplicate Ballot Paper must be made as given in the election schedule. The request made on behalf of others shall not be entertained.
 - vi. The names of the candidates will appear alphabetically on the Ballot Papers as per their names in the nomination form.
 - vii. All correspondence and clarification in matters related to FBS elections will be sent or sought from Chief Election Officer FBS IAP 2017.
 - viii. **Counting of Votes:** On the day of counting, FBS Election Commission shall keep a list of voters who have casted their votes in the FBS Election- 2017. They shall tick mark the list of those who voted. The FBS Chief Election Officer is empowered to rent out / purchase the requisite software as well personnel to handle this exercise. In case of more than one vote is found to be casted by any member, all such votes will be considered invalid and Chief Election Officer can recommend to FBS Managing Committee to take disciplinary action against such erring member.
 - ix. Contesting Candidates or their representatives (or both), coming with their identity proof are allowed to be present, during the counting of the votes.

NOTE:

1. Any dispute shall be subject to HYDERABAD jurisdiction.
2. **The Candidates / Proposers / Seconders of the nominations are required to give a self-attested Xerox Copy of their photo identity such as PAN Card / Aadhar Card/ Ration Card / Voter Card / Driving License (any one) along with the nominations .**
